














Plan of the town of Sydney New South Wales shewing Common







FRACES-We have on frequent occasions directed the attention of the colonists to this very important subject, without which, property either in crop or live stock cannot be kept seeure. As the law now stands, as far as we know, no man can be compelled by his neighbour to erect a party fence, which in many instances were the expense to devolve on one, would be more than his means could well afford or common equity require him to accomplish; and this too while the indisposed or indolent party would reap an equal advantage from a duty the entire weight of which he would so unjustly throw on the shoulders of his neighbours. It must not be concealed also, that there are many to whom it would be death to be confined within the limits of their own grants, abridging so materially as it would, the advantages they enjoy by the full liberty of grazing upon Crown land or trespassing on that of individuals. There are among such, persons, it cannot be disguised, who have fastened perhaps on fifty or a hundred acres, and who possess either of their owner on the thirds sheep or cattle to the amount of several hundreds. Many settlers are disposed to erect feaces, but the timber is in many situations so remote, that they are obliged, owing to the expense, to abandon the undertaking. To such person, we









